

CATS Security Update

Test material security is extremely important at CODESP and should also be at your district. CATS Users (those with log-in names and passwords) should ONLY include school district employees in Human Resource departments who are responsible for developing employment tests.

If there is information on the website, other than test material, that employees need to access, please find another method of retrieving that information for them without giving them a log-in name or letting them use yours. Employees can be given links to public websites provided on the website without violating the security agreement. Tutorials must be printed for them to use.

If we feel that a CATS User has been given access to our CATS system without proper authorization, we will make the log-in name Inactive until a human resource administrator from your district notifies us. We will attempt to contact individuals by email or phone prior to making them Inactive unless the violation is very apparent. We take these actions to protect your district.

Terminated employees, or those who no longer work for the HR testing function, should be made Inactive immediately. Also, if you have shared password information with anyone, change your password by logging in, clicking on My Profile, and then on Change Password.

If there is someone in your district who is accessing CATS using another individual's log-in name and password, this must be stopped immediately. This causes many security and service related problems. We send emails to the email address of the person whose log-in name and password is being used, the system can't tell who is actually logged in. If you do not want to be responsible for an individual who uses your log-in name to access CATS inappropriately, you should change your password now.

Also, we are tracking the date and time the log-in names are being used. We are looking for odd times and dates the system is accessed to ensure that the site is being used appropriately. Continued on page 2

CODESP MEMBERSHIP PAYMENT IS DUE JULY 1ST

Payment for the 2006-2007 membership year is due on July 1, 2006. If your district cannot send a purchase order or check by this date please send an email to tests@codesp.com with an estimated date payment should arrive. In the subject area of the email enter: PAYMENT. If we haven't received an Intent (available at www.codesp.com under Resources/Membership Documents) or payment information by July 1, we will make your district Inactive in CATS and you will not be able to access test information in the secure areas of the site. Payment is delinquent if it is has not been received by September 30, 2006.

Unauthorized access to the secure areas of www.codesp.com is a violation of the Security Agreement.

CATS Administrators (member-admins) are the only ones allowed to change the status of CATS Users or add new users and provide them with log-in names and passwords under <u>Add/Edit Profiles</u>. (See figure on page 3) If your member-admin has terminated from your district, contact us about issuing this status to someone else.

Log-in names must contain at least the individual's <u>first initial</u> and <u>last name</u>. If the last name is not available because it is already in use, use the last name first, followed by the first initial, and then the middle initial. If that log-in name is taken use the last name, followed by the first initial, and a number. We will not accept made-up names as log-ins.


We recently sent members an email addressed to CATS Administrators (member-admins) asking for verification of your district's CATS Users. If we do not hear from you whether this list is accurate, we will change the individuals listed in your CATS system under Add/Edit Profiles to Inactive status. This type of audit will be conducted periodically. Call us if you have any questions at 714-374-8644 and ask for Janet.

Please help us keep CATS access secure and only available to members who are truly involved in the test administration process.


As a CATS Administrator, How Can I Change a CATS User's Status?

1. Log-in. From your home page click on Add/Edit Profiles.





2. The screen above will appear listing the CATS Users for your district and their status. Click on the picture/page icon for the User whose status you want to change.



JOB DESCRIPTION BUILDER

CODESP staff has a very ambitious summer project ahead of us. We will be working on an online Job Description Builder. This service will be available to members through our website. After a short instructional tutorial, which will explain the job analysis process and offer sample forms, users will select a job family. A template will appear and the users will be asked what information they would like to add to the template. Choices will be in the form of statements that can be added to build the description. Job-related task choices will be made first and when they are submitted the system will generate task-related KSAs and competencies to choose from. The template will also include choices for other job related information. Once all of the selections are made a job description which is editable in Word will be provided. The templates will contain choices in the following areas:

JOB SUMMARY/DISTINGUISHING CHARACTERISTICS
TASKS
KNOWLEDGE, SKILLS, ABILITIES AND COMPETENCIES
EDUCATION LEVEL REQUIREMENTS
LICENSE REQUREMENTS
YEARS OF EXPERIENCE REQUIREMENTS
PHYSICAL REQUIREMENTS
WORK ENVIRONMENT
