NEW EXECUTIVE DIRECTOR SELECTED

On behalf of the CODESP Board of Directors, it is bittersweet to announce that the time has come for us to bid farewell to Marianne Tonjes, who will be retiring as the Executive Director, December 1, 2017. Marianne will pass the baton to Jonathan Koch, who has been appointed by the Board as the new Executive Director, following an extensive recruitment and selection process.

Jonathan's background and experience includes three years working for the Personnel Commissions at Hacienda La Puente USD, and two years at Rowland USD. For the past five years he has been the Director, Classified Human Resources at Oxnard School District.
